#### 4:25pm Reports

#### A. External Committee

#### 1. Financials

- a. Nell the finance committee met last week
- b. Nell briefly discusses the budget and went over the reports
- c. MG talks about timing of donations-timing is always different as to when money comes
- in. Example, one donor has not given because they are loaning us equipment for free.
- d. MG-will work with Sterling to see what best averages are on how money comes into a 3 year campaign
- e. Mike would like to see the balance sheet. MG will include it in the package monthly
- f. Michelle, there were no capital expenses in June She will go back and look at the capital expenses for the past and will do it for each month for the rest of the year. Gary had questions on the variances to net income as to cash. Michelle will look at it.
- g. Justus went over the balance of the loan  $-85\,\%$  of expenses were financed. MG, somethings are being paid for as we go. Justus says a 10% contingency was added to the bottom line. We will continue to discuss when to pay down the debt as monies come in for the Capital Campaign.

- h. Gary asked about the Capital Campaign target number. He assumed that as the money came in, that the debt would be paid down but now wonders if they should hold more of the cash. Discussion on reserve amount that we need before we pay down the debt? MG suggested that the number should be an additional 600,000. This would be six months of expenses which is 600,000. When the money starts coming in the finance committee with make recommendations as to which buckets to fill. MG -We can better assess once we have forecasted the expenses for 2020 and then determine what amount to pay down
- i. Discussion on the interest payment and the advantage of paying down as we go.
- J. Discussion on when the correct time to go public with the campaign

#### **VALUING PEOPLE**

When asked about my personal hobbies, I always respond by listing the many sporting activities in which my four children participated. My greatest accomplishment was raising my children to be outstanding individuals, so it is no wonder that I value a company that values its people. I started as a summer intern for Exxon in 1980.
